## Directions to the 2nd Annual May Membership Drive

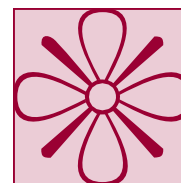
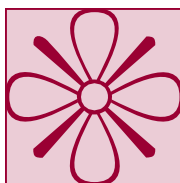
From the North: Take 81S to Exit 19 right toward Clinton St./Salina St. Bear Right (south) onto N. Salina St.—.2mi;

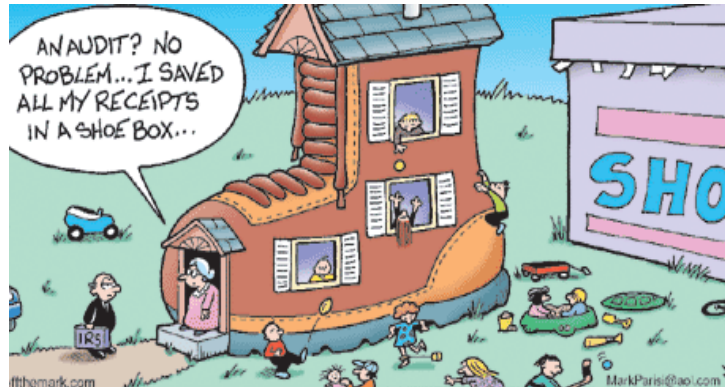
